# 1. Introduction

## 1.1 Parramatta Road Open Space and Infrastructure Schedule Overview

The Parramatta Road Open Space and Infrastructure Schedule outlines the proposed projects to support the Draft Parramatta Road Urban Transformation Strategy (draft Strategy) and achieve the vision for the Corridor which is to achieve:

*a high quality multi-use corridor with improved transport choices, better amenity and balanced growth of housing and jobs.*

The Schedule recognises that infrastructure in the Corridor must respond to population growth and change. It also recognises that some existing infrastructure is ageing or is insufficient to meet the needs of communities as they grow and change. This Schedule therefore identifies the transport, open space, community, and education facilities required to support the proposed growth across the Corridor. These projects are estimated to support up to 40,000 homes and 50,000 jobs through to 2050. By providing certainty about the nature and timing of infrastructure projects, the Parramatta Road Open Space and Infrastructure Schedule will contribute to a well-planned Corridor. It will also assist the coordination of infrastructure and services provided by state agencies, government-owned corporations, local government and the private sector.

UrbanGrowth NSW has prepared this Plan with the advice and participation of several State agencies, collaborating councils along the Corridor, and having regard to the recommendations of the supporting technical documents commissioned as part of the Parramatta Road Urban Transformation Project.

## 1.2 About the Parramatta Road Urban Transformation Program

The Parramatta Road Urban Transformation Program is led by UrbanGrowth NSW, the NSW Government's urban transformation delivery organisation. UrbanGrowth NSW's ambition is to transform city living so that it is more vibrant, connected and healthy for all.

UrbanGrowth NSW leads an Integrated Project Team (IPT) that includes the Department of Planning and Environment, Transport for NSW, Roads and Maritime Services and the WestConnex Delivery Authority. The Integrated Project Team is collaborating with councils along the corridor: the City of Sydney, Marrickville Council, Leichhardt Council, Ashfield Council, City of Canada Bay Council, Burwood City Council, Strathfield Council, Auburn City Council, Parramatta City Council and Holroyd City Council.

Under the Program, UrbanGrowth NSW has prepared the draft Parramatta Road Urban Transformation Strategy, which establishes the long-term vision for how the Parramatta Road Corridor will grow and develop to 2050. It integrates land use and built form with transport initiatives and public domain improvements to meet the Corridor's future population, housing and employment needs.

## 1.3 Next Steps, Funding and Delivery

Feedback will be sought on the Schedule as part of the exhibition of the draft Strategy. Prior to finalising the Schedule, UrbanGrowth NSW will review all feedback and continue to work with relevant stakeholders to prepare the final list of projects, process and indicative costs.

Contributions for funding the projects listed in the Schedule will come from both Local Government and State Government.

Local councils use existing development contributions systems, such as Section 94 or Section 94A Contributions Plans, and Voluntary Planning Agreements. These are widely used by councils and are well understood by the development industry and planning practitioners. These generate significant income streams for councils, which are specifically allocated to essential local infrastructure for services such as

community and child care facilities, local roads, parks and open space. Section 94 contributions will continue to go towards essential local infrastructure. Accordingly, local councils will need to amend their development contributions plans to account for the proposed population growth and local infrastructure.

The State Government is also required to fund infrastructure, particularly for classrooms, health services, transport infrastructure and regional open space and conservation areas. Regional or State infrastructure projects will be funded under the annual state budget process, which is the principal mechanism for identifying, prioritising and delivering infrastructure projects. Existing mechanisms such as the Special Infrastructure Contribution (SIC), used in the Western Sydney Growth Areas, and targeted voluntary planning agreements (VPAs) which have ensured that key State infrastructure is funded and delivered concurrent to growth could be used in the Corridor. The State Government will investigate appropriate mechanisms to ensure that key infrastructure specified in the Infrastructure and Open Space Schedule is funded in the Parramatta Road Corridor without undermining the feasibility of new development.

Following adoption of the Strategy and Schedule, the Parramatta Road infrastructure requirements will be incorporated into a broader growth infrastructure planning program across the Sydney Metro area, and will be monitored centrally by the Department of Planning and Environment, as part of the broader monitoring program. The final version of the Schedule may therefore be split into districts to align with the Department of Planning and Environment's District Plans.

#### **1.4 How to Read the Schedule**

The Parramatta Road Open Space and Infrastructure Schedule is organised by precinct and infrastructure type. Each infrastructure type is divided into a list of priority works, proposed responsibility and funding mechanism as well as an estimated cost of works.

Many projects described and listed in the Schedule require additional investigation and modelling. Some projects are also interrelated or may be subject to varying delivery timeframes (overlapping, sequential or separated in time).

All projects will be subject to standard approval, design and procurement processes. Any unfunded or partly funded initiatives will also be subject to funding availability.
